WHEREAS, military children often shoulder additional responsibilities at home in the absence of their deployed parents or guardians, and show unwavering support for their family members who serve in the military; and

WHEREAS, military children enrich the educational experience of their peers by sharing their diverse perspectives, cultures, and experiences, fostering a greater understanding and appreciation of the military community among their classmates; and

WHEREAS, military children deserve recognition and appreciation for their invaluable contributions to our schools, communities, and country;

NOW, THEREFORE, BE IT RESOLVED, that the Central Union Elementary School Board recognizes April 2024, as the Month of the Military Child, and extends its heartfelt gratitude to military children for their unwavering strength, resilience, and sacrifices; and

BE IT FURTHER RESOLVED, that the Central Union Elementary School Board encourages the participation in activities and initiatives that promote awareness and appreciation of military children, such as organizing events, assemblies, and educational programs that highlight the unique experiences and perspectives of military children; and

BE IT FURTHER RESOLVED, that the Central Union Elementary School Board expresses its commitment to providing support and resources to military children in the district, including counseling services, academic accommodations, and assistance with transitions due to deployments or relocations; and

BE IT FURTHER RESOLVED that the Central Union Elementary School Board encourages all educators, administrators, and staff in the district to demonstrate understanding, compassion, and support towards military children and to create inclusive and welcoming environments that foster the academic and emotional well-being of military children.
